ORA ET LABORA PRE-APPLICATION STATEMENT

The mission of Casting Nets Ministries, Inc. (Casting Nets) is to support the New Evangelization of the Catholic Church.

All Christ's faithful, by virtue of their baptism, are called by God to contribute to the sanctification and transformation of the world. They do this by fulfilling their own particular duties in the spirit of the Gospel and Christian discipleship. Working in lay apostolates to support the Church is a path of Christian discipleship to be encouraged. Those who work for lay apostolates continue the mission and ministry of Christ. Their service is unique and necessary for the life and growth of the Church. Employees of Casting Nets are, therefore, "coworkers in Christ Jesus" (Romans 16:3-16).

The Church needs the services of dedicated lay persons who have a clear knowledge and proper understanding of the teachings of the Church and a firm adherence to those teachings, and whose words and deeds are in conformity with the Gospel. All who seek employment or ministry in Casting Nets are expected to continue their formation and their willingness to learn and grow and to deepen their desire to serve the Lord with excellence and generosity. We recognize that persons who are non-Catholic Christians are also called by the Lord to stand before the world as a witness to his life and resurrection. We, therefore, welcome collaboration with such persons of good faith who share our Catholic vision on important social, moral and ethical issues. It is important for anyone interested in collaborating with us in our work and ministry to have an understanding of the Catholic Church and her teachings.

Our Catholic religious beliefs provide the basic framework for our ministry and our moral, ethical and social teachings. It is important for anyone interested in collaborating with us in our work and ministry to have an understanding of these teachings.

Ora et Labora is committed to promoting a "Culture of Life" from the moment of conception to the moment of natural death. We believe in the inherent dignity of the human person, created in the image and likeness of God, and possessing basic rights endowed by God, including the right to life, the right to religious liberty, and the right to be treated justly with dignity and respect. We believe human sexuality and human procreation are gifts from God to be shared through the risen Christ only by those joined in marriage, an institution that is itself instituted by Almighty God. We believe that all persons are called by God to live chaste lives by virtue of their own dignity and according to their state of life. We believe in the rights of workers to just working conditions, just wages and benefits, as well as the right to organize and join unions or other associations. We oppose all forms of oppression and exploitation, including racism, sexism, pornography, sexual abuse and harassment, and unlawful discrimination.

We embrace as a matter of faith, the teachings, policies and beliefs of the Magisterium of the Catholic Church, as defined in the Deposit of Faith. We, therefore, reject anything which is contrary to that teaching, including:

- Abortion, euthanasia, assisted suicide, artificial contraception, voluntary sterilization, and the unnecessary use of capital punishment;
- Pornography and obscenity, adultery, cohabiting in sexual relationships of any nature outside of marriage, homosexual activity, the notion of "gay marriage," and the adoption or placement of children in anything other than a traditional family setting;
- Secularism, the paring back of religious freedom rights, or the restriction of religious liberty and liberty of conscience, anti-Catholicism, or anti-Catholic biases;
- The abuse of alcohol or the use of illegal narcotics or other controlled substances; and
- Violence or the use of force to resolve social, political or religious problems.

After you have carefully reflected on what is contained in this Pre-Application Statement, we invite you to complete the Acknowledgement if you are interested in seeking membership with Ora et Labora.

Co-Working Best Practices

Ora et Labora is a **shared**, **collaborative** and **open** workspace fellowship. In order to peacefully co-exist, there are some best practices that we should all follow:

- **Be friendly**. Introduce yourself to others. You'll probably find other motivated hard workers like yourself. They can be great resources to bounce ideas off. Many a business have been formed based on common goals and complementary skills.
- Be considerate and respectful of others. When you are finished using something, put it back the way you found it. Push chairs back in, clean off work spaces, and erase white boards. Always keep in mind you are sharing the space with others.
- Advertise yourself. If you have a permanent office or desk, put something up with your logo and make sure we showcase you on the TV in the front. If you want to share or test your marketing material, bring it to our mixers and share it with the community. The more the community knows what you are about, the more buzz it can create for you.
- Need to work. When it's time for you to focus and do your productive work, the universal sign for "do not disturb" is to put on your headphones. If others have headphones on, that's a sign they have serious work to get done.
- Phone calls in the open space are fine, just talk at a normal volume and be aware it is an open space with the associated background noise. If you need privacy, are practicing aggressive negotiations or you have to yell at someone, use the phone room, take a walk outside or use the insulated quiet of your car. On the flip side, if you get disturbed easily by someone on a call, a good set of headphones are a must. If you are on the phone a lot using your booming sales voice, a private office is your best membership option.
- **Keep our space clean**. When you leave, another person will most likely sit at that same spot. So please keep it clean and trash your trash. Note that the refrigerator is emptied every Friday.
- If the coffee is out, make a pot yourself! You'll probably get lots of love for brewing good coffee.
- **Keep kitchen and bar clean**. As a fellowship family we expect each member to clean up after themselves and do their own dishes.

The services Ora et Labora Catholic Co-Working Fellowship, LLC ("Ora et Labora") provides to you, the undersigned (including but not limited to use of office space and access to Internet), are subject to the following Terms of Use ("TOU").

Ora et Labora reserves the right to update the TOU at any time. Ora et Labora will attempt to contact you to notify you of any updates within 30 days of their enactment using the contact information provided in the Membership Agreement.

2. Description of Services.

Ora et Labora may provide you with access to office space, work stations, Internet access, office equipment, conference space, knowledge resources, and other services as Ora et Labora may provide from time to time (collectively, "Services"). The Services at all times are subject to the TOU.

3. No Unlawful or Prohibited Use.

As a condition of your use of the Services, you will not use the Services for any purpose that is unlawful or prohibited by these terms, conditions and notices. You may not use the Services in any manner that could damage, disable, overburden, or impair any Ora et Labora server, or the network(s) connected to any Ora et Labora server, or interfere with any other party's use and enjoyment of any Services. You may not attempt to gain unauthorized access to any Services, or accounts, computer systems or networks connected to any Ora et Labora server or to any of the Services, through hacking, password mining or any other means. You may not obtain or attempt to obtain any materials or information through any means not intentionally made available through the Services.
